

## TURÁN INEQUALITIES FOR SYMMETRIC ORTHOGONAL POLYNOMIALS

**ABSTRACT.** A method is outlined to express a Turán determinant of solutions of a three term recurrence relation as a weighted sum of squares. This method is shown to imply the positivity of Turán determinants of symmetric Pollaczek polynomials, Lommel polynomials and  $q$ -Bessel functions.

### 1. INTRODUCTION.

Let  $\{P_n(x): n = 0, 1, 2, \dots\}$  be a sequence of polynomials orthogonal on an interval  $[a, b]$ . Then  $\{P_n(x)\}$  satisfies a three term recurrence relation

$$P_{n+1}(x) = (A_n x + B_n)P_n(x) - C_n P_{n-1}(x), \quad n = 0, 1, 2, \dots \quad (1.1)$$

In (1.1) we take  $P_{-1}(x) = 0$ , and  $C_0$  is generally unspecified. The polynomials  $\{P_n(x)\}$  are said to satisfy Turán's inequality if

$$\Delta_n(x) = P_n^2(x) - P_{n+1}(x)P_{n-1}(x) \geq 0, \quad a \leq x \leq b. \quad (1.2)$$

Paul Turán first noted that (1.2) is satisfied by the Legendre polynomials and Gabor Szegő [15] subsequently gave two elegant proofs of that fact. Since then various authors have proved that (1.2) is satisfied by the classical orthogonal polynomials of Jacobi, Hermite and Laguerre for certain ranges of the parameters involved [9], [14], [15]. A survey of Turán inequalities covering the literature until 1969 is available in [4].

In this note we will prove Turán's inequality for an important class of nonclassical orthogonal polynomials; the symmetric Pollaczek polynomials. The symmetric Pollaczek polynomials satisfy the relation (1.1) with  $B_n = 0$ . Thus they satisfy a recursion

$$E_{-1}(x) = 0, \quad E_0(x) = 1, \quad E_{n+1}(x) = A_n x E_n(x) - C_n E_{n-1}(x), \quad n = 0, 1, 2, \dots \quad (1.3)$$

We will state a general procedure which makes systematic an approach used by Szász in [14] to prove Turán inequalities for ultraspherical polynomials and Bessel functions. In [5] we used Szász's method to establish a Turán inequality for the continuous  $q$ -ultraspherical polynomials. The procedure will be outlined in Section 2.

Nevai [13] conjectured the positivity of the Turanian for orthonormal Pollaczek polynomials. His conjectures are based on graphing the Turanian for different values of  $n$  and his beautiful graphs sparked our interest and led to this work. In Section 2 we apply the Szász method to establish the positivity of the Turanian for the Pollaczek polynomials [3], [6], [16]. In Section 3 we establish a Turán inequality for modified Lommel polynomials  $\{h_{n,\nu}(x)\}$  and  $q$ -Bessel functions. One can then obtain Szász's original result for Bessel functions as a limiting case of the positivity of the Turanian for  $q$ -Bessel functions. The Hurwitz asymptotic formula for the modified Lommel polynomial, [17, §9.65(1)],

$$\lim_{n \rightarrow \infty} \frac{h_{n,\nu+1}(z)}{(2z)^{n+\nu} \Gamma(n+\nu+1)} = J_\nu(1/z), \quad (1.4)$$

will play a central role in our analysis.

## 2. THE SZÁSZ METHOD AND APPLICATIONS.

The idea here is to express  $\Delta_n$  as a sum of squares by repeatedly using (1.3). Also note that the  $P_n$ 's of (1.1) or the  $E_n$ 's of (1.3) are orthogonal if and only if the positivity condition [7, thm I.4.4]

$$A_n A_{n-1} C_n > 0, \quad n = 1, 2, \dots \quad (2.1)$$

is valid.

**THEOREM 1.** Let  $E_n$  be a sequence of polynomials generated by (1.3) and let

$$g_n := \frac{C_n^2/A_n}{C_1 C_2 \dots C_n}, \quad n > 1, \quad \zeta_n(x) = \frac{C_n/A_n}{C_1 \dots C_n} [A_n E_n^2(x)/A_{n-1} - E_{n+1}(x)E_{n-1}(x)], \quad n > 0, \quad (2.2)$$

then  $\zeta_n(x)$  has the finite series representation

$$\zeta_n(x) = \zeta_m(x) + \sum_{k=m+1}^n g_k [1 - C_{k-1}A_k/(A_{k-2}C_k)] E_{k-1}^2(x), \quad n > m > 1. \quad (2.3)$$

**PROOF.** Clearly

$$\begin{aligned} A_n x E_n^2(x) &= [E_{n+1}(x) + C_n E_{n-1}(x)] [A_{n-1} x E_{n-1}(x) - C_{n-1} E_{n-2}(x)] \\ &= x A_{n-1} [E_{n-1}(x)E_{n+1}(x) + C_n E_{n-1}^2(x)] - C_{n-1} A_n x E_n(x)E_{n-2}(x). \end{aligned} \quad (2.4)$$

Divide by  $x A_{n-1}$  and rewrite the above when  $n \geq 2$  in the form

$$\begin{aligned} \frac{A_n}{A_{n-1}} E_n^2(x) - E_{n-1}(x)E_{n+1}(x) &= \frac{C_{n-1}A_n}{A_{n-1}} [A_{n-1} E_{n-1}^2(x)/A_{n-2} - E_n(x)E_{n-2}(x)] \\ &\quad + C_n [1 - A_n C_{n-1}/(C_n A_{n-2})] E_{n-1}^2(x). \end{aligned} \quad (2.5)$$

Next multiply both sides by  $C_n/(A_n C_1 C_2 \dots C_n)$  to reduce the latter identity to

$$\zeta_n(x) = \zeta_{n-1}(x) + g_n [1 - A_n C_{n-1}/(C_n A_{n-2})] E_{n-1}^2(x), \quad n > 1, \quad (2.6)$$

which can be iterated to give (2.4) and the proof is complete.

Paul Nevai pointed out that the identity developed in the proof of Theorem 2.2 can be gotten from an identity in a paper of Dombrowski [7]. We have included the derivation of the identity for the sake of completeness and because it is a non-trivial chore to obtain it from Dombrowski's formula.

Theorem 2.2 has two interesting implications. First note that the  $g_k$ 's have a fixed sign because of the positivity condition (2.1). Indeed  $g_n$  has the same sign as  $A_0$ , that is

$$g_n A_0 > 0, \quad n > 1. \quad (2.7)$$

There is no loss of generality in always assuming  $A_0 > 0$ . We will also assume  $C_n > 0$ ,  $n \geq 1$ , since this is the case in all our applications.

**COROLLARY 1.** Assume that  $A_0 > 0$ . If  $A_k C_{k-1}/A_{k-2} C_k < 1$  for  $k > m$  and if  $\zeta_m(x) > 0$  then  $\zeta_n(x) > 0$  for all  $n > m$ . On the other hand, if  $A_k C_{k-1}/A_{k-2} C_k > 1$  for  $k > m$  and if  $\zeta_n(x) \rightarrow 0$  as  $n \rightarrow \infty$  then  $\zeta_m(x) > 0$ .

PROOF. The first statement follows immediately from (2.4). For the second statement note that if  $A_k C_{k-1}/A_{k-2} C_k > 1$  for  $k > m$  then from (2.4) we have

$$\xi_n(x) < \xi_m(x). \quad (2.8)$$

Then if  $\xi_n(x) \rightarrow 0$  as  $n \rightarrow \infty$  we have  $\xi_m(x) > 0$  and the proof is complete.

The inequality  $\xi_n(x) > 0$  is not quite of the form (1.2). However it is easy to renormalize the polynomials  $E_n(x)$  to obtain a Turán inequality like (1.2). To do this, define the monic polynomials  $P_n(x)$  by

$$P_0(x) = 1, \quad P_n(x) = E_n(x)/A_0 \cdots A_{n-1}, \quad n \geq 1.$$

Then the inequality  $\frac{A_n}{A_{n-1}} E_n^2(x) - E_{n+1}(x)E_{n-1}(x) > 0$  is equivalent to (1.2). (2.9)

Theorem 1 and Corollary 1 are the essence of the method Szász [14] used to establish the positivity of Turanians for ultraspherical polynomials and Bessel functions. An interesting feature of Theorem 1 is that signs of  $\xi_n(x)$  and the summand in (2.4) are invariant under renormalization. To see this, replace  $E_n(x)$  in (2.4) by  $c_n F_n(x)$  so  $A_n$  and  $C_n$  need to be replaced by  $c_n A_n/c_{n+1}$  and  $c_{n-1} C_n/c_{n+1}$ , respectively. A simple calculation yields the desired invariance property. Also note that the choice of the coefficient  $A_n/A_{n-1}$  in (2.3) is the only choice that makes  $\xi_n(x)$ , up to a multiplicative constant, a polynomial of degree  $2n - 2$ .

As an *example* consider the *continuous  $q$ -Hermite polynomials*  $\{H_n(x|q): n \geq 0\}$  [2, §6], with  $|q| < 1$ . They satisfy (1.3) with  $A_n = 2$ ,  $C_n = 1 - q^n$ . They are  $q$ -analogs of the Hermite polynomials. Thus

$$g_k = (1 - q^k) / [2(q; q)_{k-1}], \quad 1 - A_k C_{k-1} / A_{k-2} C_k = q^{k-1} (1 - q) / (1 - q^k), \quad (2.10)$$

where we used the notation

$$(a; q)_n := (1 - a)(1 - aq) \cdots (1 - aq^{n-1}), \quad n > 0, \quad (a; q)_0 = 1. \quad (2.11)$$

Therefore

$$\xi_n(x) = \frac{1 - q^n}{2(q; q)_n} [H_n^2(x|q) - H_{n+1}(x|q)H_{n-1}(x|q)], \quad (2.12)$$

so  $\xi_1(x) = (1 - q)/2$ . Now after some simplification the case  $m = 1$  of (2.4) reduces to

$$\frac{(1 - q^n)}{(q; q)_n} [H_n^2(x|q) - H_{n+1}(x|q)H_{n-1}(x|q)] = \sum_{k=0}^{n-1} \frac{(1 - q)q^k}{(q; q)_k} H_k^2(x|q). \quad (2.13)$$

The above identity is a Turán inequality for the continuous  $q$ -Hermite polynomials. The identity (2.13) is a  $q$ -analog of the Hermite polynomial identity

$$H_n^2(x) - H_{n-1}(x)H_{n+1}(x) = 2^n n! \sum_{k=0}^{n-1} \frac{1}{k!} H_k^2(x), \quad n > 0. \quad (2.14)$$

We will briefly show how  $H_n(x)$  is a limiting case of  $H_n(x|q)$ . Since

$$H_{n+1}(x|q) = 2xH_n(x|q) - (1 - q^n)H_{n-1}(x|q), \quad (2.15)$$

then

$$p_n(x) := \left( \frac{2}{1 - q} \right)^{n/2} H_n \left( x \left( \frac{1 - q}{2} \right)^{1/2} | q \right) \quad (2.16)$$

satisfies

$$p_{n+1}(x) = 2xp_n(x) - \frac{2(1 - q^n)}{1 - q} p_{n-1}(x) \quad (2.17)$$

and

$p_0(x) = 1, p_1(x) = 2x$ . As  $q \rightarrow 1$  the above recurrence relation tends to the recurrence relation satisfied by the Hermite polynomials. This is how one can find the rescaling necessary to go from the continuous  $q$ -Hermite polynomials to the Hermite polynomials. We only need to show that  $\lim_{q \rightarrow 1} p_n(x)$  exists for every  $n$ . This easily follows by induction using the recurrence relation and initial conditions. A simple calculation now shows how (2.13) tends to the corresponding result for Hermite polynomials as  $q \rightarrow 1$ .

An important example of Theorem 2.2 is provided by the symmetric Pollaczek polynomials [3, §6], [16]. They satisfy the recursion (1.3) with

$$A_n = \frac{2(n+a+\lambda)}{n+1}, \quad C_n = \frac{n+2\lambda-1}{n+1}. \tag{2.18}$$

The polynomials defined by (1.3) and (2.18) are orthogonal if  $\lambda \geq 0$  and  $a + \lambda \geq 0$ . We find from (2.18) that

$$1 - \frac{A_n C_{n-1}}{A_{n-2} C_n} = \frac{2[an + (\lambda - 1)(a + \lambda)]}{n(n + a + \lambda - 2)(n + 2\lambda - 1)}. \tag{2.19}$$

The denominator on the right side of (2.19) is positive for  $n \geq 3, a + \lambda \geq 0, \lambda \geq 0$ . The numerator is positive for large  $n$  only where  $a > 0$ , thus we require  $a > 0$ . Taking  $m = 2$  in (2.4) we have

$$\zeta_n(x) = \zeta_2(x) + \sum_{k=3}^n g_k \left[ \frac{1 - C_{k-1} A_k}{A_{k-2} C_k} \right] E_{k-1}^2 \tag{2.20}$$

for  $n \geq 3$ . For  $\zeta_2(x)$  we have from (2.3)

$$\zeta_2(x) = \frac{1}{C_1 A_2} \left\{ \frac{4(a + \lambda)[a\lambda + a + \lambda^2 - \lambda]x^2}{3} + \frac{2(a + \lambda + 2)\lambda^2}{3(a + \lambda + 1)} \right\}. \tag{2.21}$$

Then  $\zeta_2(x) > 0$  for  $-1 < x < 1$  if

$$a\lambda + a + \lambda^2 - \lambda > 0. \tag{2.22}$$

When (2.10) holds then  $\zeta_n(x) > 0, -1 < x < 1, a > 0, a + \lambda > 0, n = 2, 3, \dots$ , and then inequality (2.6) holds for the symmetric Pollaczek polynomials. The region defined by (2.10),  $a > 0, \lambda > 0$ , in which the Turán inequality (2.6) holds is shown in Figure 1. The region is the area outside the shaded region bounded by the curve  $a = \frac{\lambda(1-\lambda)}{1+\lambda}$  and  $a > 0, \lambda > 0$ .

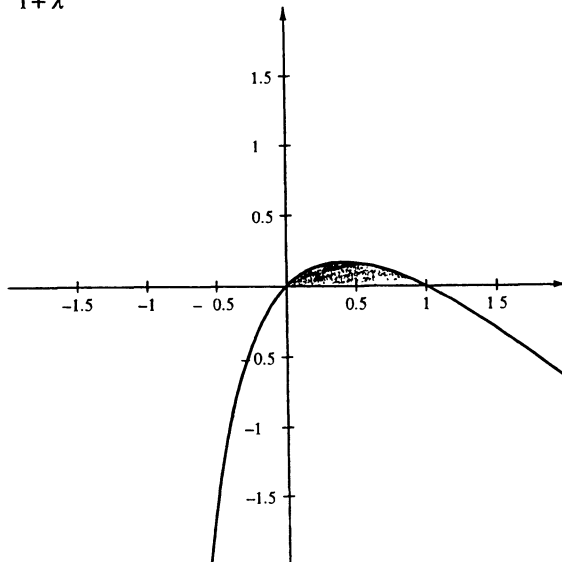

### 3. LOMMEL POLYNOMIALS AND $q$ -BESSEL FUNCTIONS.

Dickinson, Pollak and Wanier [8] studied a class of polynomials generated by

$$p_{-1,\nu}(x) := 0, \quad p_{0,\nu}(x) := 1, \quad p_{n+1,\nu}(x) = c_{n+\nu} x p_{n,\nu}(x) - p_{n-1,\nu}(x), \quad n \geq 0. \quad (3.1)$$

The positivity condition (2.1) implies that all the  $c_{n+\nu}$ 's have the same sign. Since we may replace  $x$  by  $-x$  there is no loss of generality in assuming,  $c_{n+\nu} > 0$ . Later Goldberg [11] corrected a minor error in [8] and proved that if  $c_{n+\nu} \rightarrow \infty$  as  $n \rightarrow \infty$  and

$$\sum_{n=0}^{\infty} [1/c_{n+\nu} c_{n+\nu+1}], \quad (3.2)$$

converges then there exists an even entire function  $E_\nu(z)$  such that

$$\lim_{n \rightarrow \infty} \frac{p_{n,\nu}(z)}{z^n c_\nu c_{\nu+1} \cdots c_{\nu+n-1}} = E_\nu(1/z). \quad (3.3)$$

Furthermore if

$$0 < x_1 < x_2 < \cdots \quad (3.4)$$

denote the positive zeros of  $E_\nu(z)$  then the polynomials  $\{p_{n,\nu}(x)\}$  are orthogonal with respect to a discrete measure whose support is  $\left\{\frac{1}{x_n} : n > 0\right\} \cup \{0\} \cup \left\{-\frac{1}{x_n} : n > 0\right\}$ .

The Lommel polynomials  $\{h_{n,\nu}(x)\}$  correspond to the case  $c_{n+\nu} = 2(n+\nu)$  [17, §9.63(2)].

**THEOREM 2.** Assume that  $c_{n+\nu}$  is monotone increasing. If  $c_{n+\nu+1}/c_{n+\nu}$  is bounded and the series (3.2) converges then

$$p_{n,\nu}^2(1/x_k) - p_{n+1,\nu}(1/x_k) p_{n-1,\nu}(1/x_k) > (1 - c_{n+\nu}/c_{n+\nu+1}) p_{n,\nu}^2(1/x_k) > 0, \quad k = 1, 2, \dots \quad (3.5)$$

**PROOF.** In the present case  $A_k C_{k-1}/A_{k-2} C_k = c_{k+\nu}/c_{k+\nu-2} > 1$ . Also

$$\zeta_n(x) = p_{n,\nu}^2(x)/c_{n+\nu-1} - p_{n+1,\nu}(x) p_{n-1,\nu}(x)/c_{n+\nu}. \quad (3.6)$$

It is known that when the moment problem associated with orthonormal polynomials  $\{p_n(x)\}$  has a unique solution then the corresponding measure has a point mass at  $x = u$  if and only if  $\sum_{n=0}^{\infty} p_n^2(u)$  converges [1]. In the case under consideration the orthonormal polynomials are  $\sqrt{c_{n+\nu}/c_\nu} p_{n,\nu}(x)$ , hence  $\sum_{n=0}^{\infty} c_{n+\nu} p_{n,\nu}^2(1/x_k)$  converges for all  $k \geq 1$  and  $\zeta_n(1/x_k) \rightarrow a$  as  $n \rightarrow \infty$ . Thus Corollary 1 is applicable and for  $n > 0$  we have

$$\zeta_n(1/x_k) = \sum_{m=n+1}^{\infty} \frac{1}{c_{m+\nu}} (-1 + c_{m+\nu}/c_{m+\nu-2}) p_{m-1,\nu}^2(1/x_k) > \text{the term } m = n+1, \quad (3.7)$$

and (3.5) follows. This completes the proof.

Theorem 2 is the only Turán inequality known for a system of discrete orthogonal polynomials. It is interesting to note that (3.7) holds on the spectrum and may not necessarily hold on the interval of orthogonality  $(-1/x_1, 1/x_1)$ . In the case of Lommel polynomials  $h_{n,\nu}(x)$  the  $x_k$ 's are the positive zeros of  $J_{\nu-1}(z)$ . We have calculated the roots of  $\zeta_n(x)$  when  $n = 8$  and  $\nu = 1/2$ . When  $\nu = 1/2$  then  $x_k = (k - 1/2)\pi$ .  $\zeta_8(x)$  is symmetric, of degree 14, and has four complex roots and 10 real symmetric roots. Denoting the positive real roots by  $r_1 < r_2 < r_3 < r_4 < r_5$  we find that

$$0 < \frac{1}{x_3} < r_1 < r_2 < \frac{1}{x_2} < r_3 < r_4 < \frac{1}{x_1} < r_5. \quad (3.8)$$

This behavior confirms Theorem 2. That  $1/x_1$  lies between  $r_4$  and  $r_5$  becomes numerically evident only when these numbers are calculated to a high level of precision. To 17 places we have

$$\begin{aligned} r_4 &= .63661942770432881 \\ \frac{1}{x_1} &= .636619772367581343 \\ r_5 &= .63661977236760431 . \end{aligned}$$

Observe that Hurwitz's formula (1.4) and (3.3) indicate that in the case of Lommel polynomials  $\{h_{n,\nu+1}(x)\}$  the entire function  $E_\nu(z)$  is  $\Gamma(\nu+1)(2/z)^\nu J_\nu(z)$ . Goldberg [11] noted the three term recurrence relation

$$p_{n,\nu}(x) = xc_\nu p_{n-1,\nu+1}(x) - p_{n-2,\nu+2}(x), \quad n > 0. \quad (3.9)$$

If we now let  $n \rightarrow \infty$  in (3.9) we obtain from (3.3) the three term recurrence relation

$$E_{\nu+1}(x) = E_\nu(x) + \left[ x^2/c_\nu c_{\nu+1} \right] E_{\nu+2}(x). \quad (3.10)$$

If we denote  $E_{\nu+n+1}(z)$  by  $F_n(z)$  we will find that (3.10) resembles (1.3) with

$$A_n = c_{\nu+n} c_{\nu+n+1}/x^2, \quad C_n = c_{\nu+n} c_{\nu+n+1}/x^3. \quad (3.11)$$

Although now  $A_n$  and  $C_n$  depend on  $x$  the proof of Theorem 1 remains valid and if  $c_{n+\nu}$  increases with  $\nu$  and the corresponding  $\zeta_m(x) \rightarrow 0$  as  $m \rightarrow \infty$  then

$$\zeta_m(x) > g_{m+1}(x) \left[ 1 - c_{m+\nu+1}/c_{m+\nu-1} \right] F_m^2(x) \quad (3.12)$$

which is equivalent to

$$F_m^2(x) - F_{m+1}(x)F_{m-1}(x) > 0 \quad (3.13)$$

This establishes the next result.

**THEOREM 3.** Let  $c_{\nu+n}$  increase with  $\nu$  such that the series (3.2) converges. If

$$\left[ \frac{c_{n+\nu+1}}{c_{n+\nu-1}} E_{n+\nu+1}^2(x) - E_{n+\nu} E_{n+\nu+2}(x) \right] \prod_{k=1}^n \frac{x^2}{c_{k+\nu} c_{k+\nu+1}} \rightarrow 0 \quad (3.14)$$

as  $n \rightarrow \infty$  then for  $x > 0$

$$E_\nu^2(x) - E_{\nu+1}(x)E_{\nu-1}(x) > 0, \quad \nu > 0. \quad (3.15)$$

Two interesting examples follow from Theorem 3.10. Firstly in the case  $c_{\nu+n} = 2(n+\nu+1)$ ,  $E_\nu(x) = (2/x)^\nu \Gamma(\nu+1) J_\nu(x)$  and  $E_\nu(x) \rightarrow 1$  as  $\nu \rightarrow \infty$ , hence the assumptions in Theorem 3 are fulfilled for  $\nu > 0$ . Thus (3.11) reduces to

$$J_\nu^2(x) - J_{\nu+1}(x)J_{\nu-1}(x) > \frac{1}{\nu+1} J_\nu^2(x), \quad \nu > 0, \quad x > 0. \quad (3.16)$$

Szász [14] proved (3.16) using recursions. The second example is the case of  $q$ -Bessel functions of Jackson. Renormalized  $q$ -Lommel polynomials satisfy (3.1) with

$$c_\nu = 2q^{1/4} (q^{-\nu/2} - q^{\nu/2}), \quad E_\nu(x) = (2/x)^\nu \frac{(q; q)_\infty}{(q^{\nu+1}; q)_\infty} J_\nu^{(2)}(x; q), \quad (3.17)$$

where we followed the notation

$$J_\nu^{(2)}(x; q) := \frac{(q^{\nu+1}; q)_\infty}{(q; q)_\infty} \sum_{n=0}^{\infty} \frac{(-1)^n (x/2)^{\nu+2n}}{(q; q)_n (q^{\nu+1}; q)_n} q^{n(n+\nu)}, \quad (3.18)$$

for Jackson's  $q$ -Bessel functions [12]. Jackson's original notation was different but the current notation is due to Ismail and since it was introduced in [12] it has become widely used especially after Gasper and Rahman adopted it in their excellent book [10]. The limiting relation (3.14) is satisfied since

$$\lim_{\nu \rightarrow \infty} (x/2)^\nu J_\nu^{(2)}(x; q) = 1/(q; q)_\infty, \quad (3.19)$$

which follows from (3.18) and the assumption  $0 < q < 1$ . Now (3.15) yields the Turán inequality

$$\left[ J_\nu^{(2)}(x; q) \right]^2 - J_{\nu+1}^{(2)}(x; q) J_{\nu-1}^{(2)}(x; q) > \frac{q^\nu (1-q)}{1-q^{\nu+1}} \left[ J_\nu^{(2)}(x; q) \right]^2, \quad \nu > 0, \quad x > 0. \quad (3.20)$$

It is clear from (3.18) that  $(1-q)^{-\nu} J_{\nu}^{(2)}(x(1-q);q) \rightarrow J_{\nu}(x)$  as  $q \rightarrow 1^-$ . The limiting case  $q \rightarrow 1^-$  of (3.20), after replacing  $x$  by  $(1-q)x$ , is the inequality

$$J_{\nu}^2(x) - J_{\nu+1}(x)J_{\nu-1}(x) > \frac{1}{\nu+1} J_{\nu}^2(x), \quad (3.21)$$

mentioned earlier.

## Special Issue on Intelligent Computational Methods for Financial Engineering

### Call for Papers

As a multidisciplinary field, financial engineering is becoming increasingly important in today's economic and financial world, especially in areas such as portfolio management, asset valuation and prediction, fraud detection, and credit risk management. For example, in a credit risk context, the recently approved Basel II guidelines advise financial institutions to build comprehensible credit risk models in order to optimize their capital allocation policy. Computational methods are being intensively studied and applied to improve the quality of the financial decisions that need to be made. Until now, computational methods and models are central to the analysis of economic and financial decisions.

However, more and more researchers have found that the financial environment is not ruled by mathematical distributions or statistical models. In such situations, some attempts have also been made to develop financial engineering models using intelligent computing approaches. For example, an artificial neural network (ANN) is a nonparametric estimation technique which does not make any distributional assumptions regarding the underlying asset. Instead, ANN approach develops a model using sets of unknown parameters and lets the optimization routine seek the best fitting parameters to obtain the desired results. The main aim of this special issue is not to merely illustrate the superior performance of a new intelligent computational method, but also to demonstrate how it can be used effectively in a financial engineering environment to improve and facilitate financial decision making. In this sense, the submissions should especially address how the results of estimated computational models (e.g., ANN, support vector machines, evolutionary algorithm, and fuzzy models) can be used to develop intelligent, easy-to-use, and/or comprehensible computational systems (e.g., decision support systems, agent-based system, and web-based systems)

This special issue will include (but not be limited to) the following topics:

- **Computational methods:** artificial intelligence, neural networks, evolutionary algorithms, fuzzy inference, hybrid learning, ensemble learning, cooperative learning, multiagent learning

- **Application fields:** asset valuation and prediction, asset allocation and portfolio selection, bankruptcy prediction, fraud detection, credit risk management
- **Implementation aspects:** decision support systems, expert systems, information systems, intelligent agents, web service, monitoring, deployment, implementation
