

# WAVELET-TYPE FRAMES AND WAVELET-TYPE BASES

The concepts of basis and frame are studied in the classical literature of functional analysis, Fourier analysis, and wavelet theory in a wide range. In this paper, we consider an operator-theoretic approach to discrete frame theory on a separable Hilbert space. For this purpose, we define a special type of frames and bases, called wavelet-type frames and wavelet-type bases, obtained by acting with a family of bounded linear operators on some vectors, and then investigate the elementary properties of these concepts.

## 1. Introduction

The idea of this paper comes from wavelets theory. In classical functional analysis, a basis of a separable Hilbert space is a countable subset of  $H$  with certain properties. In the wavelet theory, a basis is made by a countable family of unitary operators and a single number (or finite number) of vectors in  $H$ . In fact, if  $U$  is a unitary system on  $H$  and  $\Psi$  is the mother wavelet corresponding to it, then  $U\Psi$  is an orthonormal basis for  $H$ . In other words, the bases which one studies in the wavelet theory are of this form.

Hence generally, a frame  $\{x_n : n \in \mathbb{J}\}$  for  $H$  is called a *wavelet-type frame* if there exist a family  $\{f_i : i \in \mathbb{J}\}$  of bounded operators on  $H$  and a vector  $h \in H$  such that  $x_i = f_i h$  for each  $i \in \mathbb{J}$ . The vector  $h$  is called a *framer vector*.

Similarly, a normalized tight frame (Riesz basis, orthonormal basis)  $\{x_j : j \in \mathbb{J}\}$  is called a *wavelet-type normalized tight frame* (*wavelet-type Riesz basis*, *wavelet-type orthonormal basis*) if there exist a family  $\{f_i : i \in \mathbb{J}\}$  of bounded linear invertible operators on  $H$  and a vector  $h \in H$  such that  $x_i = f_i h$  for each  $i \in \mathbb{J}$ .

Our idea in this paper is based on the wavelet-type frames, which we organize as follows.

In Section 2, definitions and some elementary properties of framers and wavelet-type frames, basers and wavelet-type bases are given. Then, we will explain the relations between, framers and normal framers, normal framers and orthonormal basers, framers and Riesz basers, and finally, framers and the canonical dual of it. These results will be needed in Section 3.

Section 3 is devoted to the study of the structure of framers and basers, by defining the concepts of complement, strong complement, strongly disjoint complement, and similarity. We will show that the complement of each wavelet-type frame is of wavelet-type. The same result will be proven for the strong complement, the strongly disjoint complement, and similarity. Also, the problem of construction of a baser from a framer on a Hilbert space will be considered in this section. Indeed by using a complement framer, we can find a (Riesz or orthonormal) baser.

## 2. Elementary properties of framers and basers

Let  $H$  be a separable Hilbert space, and let  $B(H)$  denote the algebra of all bounded linear operators on  $H$ . Let  $\mathbb{J}$  denote a generic countable (or finite) index set such as  $\mathbb{N}$ ,  $\mathbb{Z}$ , and so forth.

In the notations, we follow [8].

**Definition 2.1.** Let  $H$  be a separable complex Hilbert space and  $B(H)$  the algebra of all bounded linear operators on  $H$ . If  $U = \{f_j : j \in \mathbb{J}\}$  is a countable subset of bounded operators on  $H$ , and  $\lambda \in H$ , then the following hold.

- (i)  $(\{f_j\}, \lambda)$  is a *framer* on  $H$  if  $U\lambda = \{f_j\lambda : f_j \in U\}$  is a frame with frame bounds  $A, B$ , for  $H$ . Also  $A, B$  are called *framer bounds*.
- (ii)  $(\{f_j\}, \lambda)$  is a *tight framer* on  $H$  if the  $f_j$ 's are invertible, for each  $j \in \mathbb{J}$ , and  $U\lambda = \{f_j\lambda : f_j \in U\}$  is a tight frame for  $H$ .
- (iii)  $(\{f_j\}, \lambda)$  is a *normal framer* on  $H$  if the  $f_j$ 's are invertible, for each  $j \in \mathbb{J}$ , and  $U\lambda = \{f_j\lambda : f_j \in U\}$  is a normalized tight frame for  $H$ .
- (iv) Finally,  $(\{f_j\}, \lambda)$  is called (*an orthonormal-Riesz*) *baser* on  $H$  if the  $f_j$ 's are invertible, for each  $j \in \mathbb{J}$ , and  $U\lambda = \{f_j\lambda : f_j \in U\}$  is (*an orthonormal-Riesz*) basis for  $H$ .

### 2.1. Examples.

- (a) Let  $H = l^2(\mathbb{N} \cup \{0\})$  and  $T : l^2(\mathbb{N} \cup \{0\}) \rightarrow l^2(\mathbb{N} \cup \{0\})$  is defined by  $T(x_1, x_2, \dots) = (0, x_1, x_2, \dots)$ , then  $T$  is a bounded invertible operator with  $\|T\| = 1$ . Set  $T_n = T^n$  with

$$T^n(x_1, x_2, \dots) = (\underbrace{0, 0, \dots, 0}_{n \text{ times}}, x_1, x_2, \dots), \quad T_0 = T, \quad \lambda = (1, 0, 0, \dots), \quad (2.1)$$

then  $(\{T_n : n \in \mathbb{N} \cup \{0\}\}, \lambda)$  is an orthonormal baser on  $H$ .

- (b) Let  $H = L^2[0, 1]$ , define  $T(x(t)) = \int_0^t x(q) dq$  and by induction,  $T^n(x(t)) = (1/n)T^{n-1}(x(t))$ , if  $x(t) = 1$ , then  $T(x(t)) = t$ ,  $T^2(x(t)) = (1/2)t^2$ , ...,  $T^n(x(t)) = (1/n!)t^n$ , and  $\{1, t, (1/2)t^2, \dots, (1/n!)t^n, \dots\}$  is a tight frame (see [8]), so if we define  $T_n = T^n$ ,  $n \in \mathbb{N}$ , then  $(\{T_n : n \in \mathbb{N}\}, x(t))$  is a tight framer on  $H$ .
- (c) Let  $\Psi$  be the mother wavelet corresponding to unitary system  $U$  for Hilbert space  $H$ , then  $(U, \Psi)$  is an orthonormal baser on  $H$ .

**THEOREM 2.2.** Let  $\{f_n : n \in \mathbb{J}\}$  be a normal framer on  $H$ . Then there exist a Hilbert space  $K$  and a normal baser  $U = \{T_n : n \in \mathbb{J}\}$  of  $K$  such that  $\theta f_n \theta^* = PT_n$ , or  $\theta f_n(x) = PT_n(\theta(x))$ ,

$n \in \mathbb{J}$ , where  $\theta : H \rightarrow \theta(H)$  is a unitary operator and  $P : K \rightarrow \theta(H)$  is the orthogonal projection of  $H$  onto  $\theta(H)$ .

*Proof.* Since  $\{f_n : n \in \mathbb{J}\}$  is a normal framer, there exists  $h \in H$  such that  $\{f_n h : n \in \mathbb{J}\}$  is a normalized tight frame for  $H$ . Set  $K = l^2(\mathbb{J})$  and define  $\theta_0 : H \rightarrow K$  by  $\theta_0(x) = (\langle x, f_n h \rangle)_{n \in \mathbb{J}}$  as the usual frame transform which is an isometry. Thus,  $H$  can be embedded into  $K$  by identifying  $H$  with  $\theta_0(H)$ . Since  $\theta : H \rightarrow \theta_0(H) \subset K$  with  $\theta(x) = \theta_0(x)$  is onto, so it is unitary. Define  $T_1 : K \rightarrow K$  as identity and

$$T_2((x_n)_{n \in \mathbb{J}}) = (0, x_1, x_2, \dots), \dots, T_m((x_n)_{n \in \mathbb{J}}) = (\underbrace{0, 0, \dots, 0}_{m-1 \text{ times}}, x_1, x_2, \dots), \quad (2.2)$$

then  $\{T_n\}_{n \in \mathbb{J}}$  with  $e_1 = (1, 0, 0, \dots)$  is an orthonormal baser on  $K$ . Since  $P$  is a projection, so  $P = P^*$ , and we have  $\langle \theta f_m(x), PT_n(\theta(x)) \rangle = \langle P\theta f_m(x), T_n(\theta(x)) \rangle = \langle \theta f_m(x), T_n(\theta(x)) \rangle = \langle f_m(x), f_n(\theta(x)) \rangle = \langle \theta(f_m(x)), \theta f_n(\theta(x)) \rangle$ , hence  $\langle \theta f_m(x), PT_n(\theta(x)) - \theta f_n(\theta(x)) \rangle = 0$ . But by definition of framer, we have  $\langle \theta(y), T_n(e_1) \rangle = \langle y, f_n(h) \rangle$ . On the other hand, since  $f_m(h)$ 's span  $H$ , thus vectors  $\theta f_m(h)$  span  $\theta(H)$ , so  $(PT_n e_1 - \theta(f_n h)) \perp \theta(H)$ , and hence  $(PT_n \theta(x) - \theta(f_n(x))) \perp \theta(H)$ . However, the range of  $P$  is  $\theta(H)$ , and therefore  $PT_n \theta(x) - \theta(f_n(x)) = 0$  and  $PT_n \theta(x) = \theta(f_n(x))$ .  $\square$

The relation between normal framers and orthonormal basers will be shown in the following theorem.

**THEOREM 2.3.** *Let  $H$  be a Hilbert space, then  $(\{f_n : n \in \mathbb{J}\}, h_1)$  is a normal framer on  $H$  if and only if there exist a Hilbert space  $M$  and a normal framer  $(\{g_n : n \in \mathbb{J}\}, h_2)$  on  $M$  such that  $(\{f_n \oplus g_n : n \in \mathbb{J}\}, h_1 \oplus h_2)$  is an orthonormal baser on  $H \oplus M$ .*

*Proof.* By Theorem 2.2, there exist a Hilbert space  $K$  and an orthonormal baser  $(\{u_n : n \in \mathbb{J}\}, e_1)$  on  $K$  such that  $\theta_0(f_n(x)) = Pu_n(\theta_0(x))$ , where  $\theta_0 : H \rightarrow K$  is the frame transform corresponding to normalized tight frame  $\{f_n h_1 : n \in \mathbb{J}\}$ , which is an isometry. Now set  $M = (I - P)K$  and  $g_n = (I - P)u_n$ , where  $I$  is the identity operator on  $K$ , then the set  $\{g_n e_1 : n \in \mathbb{J}\}$  is a normalized tight frame for  $M$ , hence  $(\{g_n : n \in \mathbb{J}\}, e_1)$  is a normal framer on  $M$  and  $(\{\theta_0(f_n) \oplus g_n : n \in \mathbb{J}\}, \theta_0(h_1) \oplus h_2)$  is an orthonormal baser on  $\theta_0(H) \oplus M$ . Since  $\theta_0 : H \rightarrow K$  is an isometry, if we define  $\theta : H \rightarrow \theta_0(H)$  by  $\theta(x) = \theta_0(x)$ , then  $\theta$  is unitary, so  $\theta \oplus I$  and  $\theta^{-1} \oplus I$  are unitaries. Since  $(\{\theta_0(f_n) \oplus g_n : n \in \mathbb{J}\}, \theta_0(h_1) \oplus h_2)$  is an orthonormal baser on  $\theta_0(H) \oplus M$ , hence

$$\begin{aligned} & (\{(\theta^{-1} \oplus I)(\theta_0(f_n) \oplus g_n) : n \in \mathbb{J}\}, (\theta^{-1} \oplus I)(\theta_0(h_1) \oplus h_2)) \\ & = (\{f_n \oplus g_n : n \in \mathbb{J}\}, h_1 \oplus h_2) \end{aligned} \quad (2.3)$$

is an orthonormal baser on  $(\theta^{-1} \oplus I)(\theta_0(H) \oplus M) = H \oplus M$  as required.  $\square$

The next theorem show that a Riesz baser is the image of an orthonormal baser under a bounded invertible operator.

**THEOREM 2.4.** *Let  $(\{v_n : n \in \mathbb{J}\}, \lambda_1)$  be a Riesz baser on Hilbert space  $H$ , then there exist a bounded invertible operator  $\theta$  and an orthonormal baser  $(\{u_n : n \in \mathbb{J}\}, \lambda_2)$  such that  $\theta v_n(x) =$*

$u_n(\theta(x))$ . Likewise, a framer is the image of a normal framer under a bounded invertible operator.

*Proof.* Let  $(\{v_n : n \in \mathbb{J}\}, \lambda_1)$  be a Riesz baser on Hilbert space  $H$ , then by the proof of Theorem 2.2, we have  $\theta_0(H) = K$  and  $\theta_0^{-1}(K) = H$ , hence if  $(\{u_n : n \in \mathbb{J}\}, \lambda_2)$  is the normal baser as mentioned in Theorem 2.2, then  $\theta_0^{-1}(u_n(\theta_0(x))) = v_n(x)$ , or  $\theta_0 v_n(x) = u_n(\theta_0(x))$ .

Let  $(\{u_n : n \in \mathbb{J}\}, h)$  be a normal framer on  $H$  and  $T$  a bounded linear invertible operator. Define  $f_n(x) = Tu_n(x)$ , then for  $x_0 \in H$ , we have  $\sum_j |\langle x_0, f_j(h) \rangle|^2 = \sum_j |\langle x_0, Tu_j(h) \rangle|^2 = \sum_j |\langle T^* x_0, u_j(h) \rangle|^2 = \|T^* x_0\|^2$ .

But

$$\|T^* x_0\| \leq \|T^*\| \|x_0\| = \|T\| \|x_0\|. \quad (2.4)$$

Since  $T^{-1}$  exists, so  $T^*$  is invertible and  $T^{*-1} = (T^{-1})^*$ , thus  $\|T^{*-1}\| = \|(T^{-1})^*\| = \|T^{-1}\|$ , hence

$$\|x_0\| = \|T^{*-1} T^*(x_0)\| \leq \|T^{-1}\| \|T^*(x_0)\|. \quad (2.5)$$

Now (2.4) and (2.5) imply that  $\|T^{-1}\|^{-1} \|x_0\| \leq \|T^*(x_0)\| \leq \|T\| \|x_0\|$ . Therefore,  $\|T^{-1}\|^{-2} \|x_0\|^2 \leq \sum_j |\langle x_0, f_j(h) \rangle|^2 \leq \|T\|^2 \|x_0\|^2$ , hence  $\{f_n(Th) : n \in \mathbb{J}\}$  is a frame with frame bounds  $A \geq \|T^{-1}\|^{-2}$  and  $B \leq \|T\|^2$ , and consequently  $(\{f_n : n \in \mathbb{J}\}, h)$  is a framer.  $\square$

In Theorem 2.3, we showed that each normal framer is the direct summand of a normal baser. We will prove the same result for Riesz basers as follows.

**THEOREM 2.5.** *Let  $(\{f_n : n \in \mathbb{J}\}, h)$  be a framer on Hilbert space  $H$ . Then there exist a Hilbert space  $M$  and a normal framer  $(\{u_n : n \in \mathbb{J}\}, \lambda)$  on  $M$  such that  $(\{f_n \oplus u_n : n \in \mathbb{J}\}, h \oplus \lambda)$  is a Riesz baser on  $H \oplus M$ .*

*Proof.* Since by Theorem 2.4 each framer is the image of a normal framer under a bounded invertible operator, there exist a normal framer  $(\{v_n : n \in \mathbb{J}\}, \lambda_1)$  on  $H$  and invertible operator  $T : H \rightarrow H$  such that  $Tv_n(x) = f_n(x)$  for all  $n \in \mathbb{J}$ . So by Theorem 2.3, there are a Hilbert space  $M$  and a normal framer  $(\{u_n : n \in \mathbb{J}\}, \lambda_2)$  on  $M$  such that  $(\{\theta(v_n) \oplus u_n : n \in \mathbb{J}\}, \theta(\lambda_1) \oplus \lambda_2)$  is an orthonormal baser on  $\theta(H) \oplus M$ . Since  $T$  and  $\theta^{-1}$  are invertible, so  $T\theta^{-1}$  is invertible,  $(T\theta^{-1} \oplus I)(\theta(\lambda_1) \oplus \lambda_2) = T\lambda_1 \oplus \lambda_2$ , and  $(T\theta^{-1} \oplus I)(\theta(v_n) \oplus u_n) = T(v_n) \oplus u_n = f_n \oplus u_n$ . Hence, Theorem 2.4 implies that  $(\{f_n \oplus u_n : n \in \mathbb{J}\}, T\lambda_1 \oplus \lambda_2)$  is a Riesz baser on  $H \oplus M$ .  $\square$

**LEMMA 2.6.** *Let  $(\{u_n : n \in \mathbb{J}\}, \lambda_2)$  be a Riesz baser on  $H$  and let  $P$  be a projection from  $H$  onto a subspace  $PH$  of  $H$ , then  $\{Pu_n : n \in \mathbb{J}\}$  is a framer on  $PH$ .*

*Proof.* Let  $T : H \rightarrow H$  be a bounded invertible operator on  $H$ , and let  $Q$  be a selfadjoint projection, set  $P = TQT^{-1}$  and let  $v_n = T^{-1}u_n$ , another Riesz baser on  $H$ . For  $x \in QH$ , we have  $\sum_n |\langle x, Qv_n(T^{-1}\lambda_2) \rangle|^2 = \sum_n |\langle Qx, v_n(T^{-1}\lambda_2) \rangle|^2 = \sum_n |\langle x, v_n(T^{-1}\lambda_2) \rangle|^2$ , so by the definition of framer,  $\{Qv_n : n \in \mathbb{J}\}$  is a framer on  $H$ . Now, since  $T|_{QH}$  is a bounded invertible operator from  $QH$  onto  $PH$ , so  $\{TQv_n : n \in \mathbb{J}\}$  is a framer on  $PH$ .  $\square$

**THEOREM 2.7.** *A pair  $(\{f_n : n \in \mathbb{J}\}, \lambda_1)$  is a framer on a Hilbert space  $H$  if and only if there exist a Hilbert space  $M$  and a normal framer  $(\{u_n : n \in \mathbb{J}\}, \lambda_2)$  on  $M$  such that  $(\{f_n \oplus u_n : n \in \mathbb{J}\}, \lambda_1 \oplus \lambda_2)$  is a Riesz baser on  $H \oplus M$ . In short, framers are precisely the inner direct summands of Riesz basers.*

The proof is obvious.

**Remark 2.8.** The last theorem allows us to generalize the concept of framer in Banach spaces to be simply an inner direct summand of a Riesz baser. In this case, the index set should be  $\mathbb{N}$ . For instance, a Schauder framer would be an inner direct summand of a Schauder baser. Similarly, the bounded unconditional framer would be an inner direct summand of a bounded unconditional baser.

In the following theorems, we will prove that coisometries preserve the structure of framers, that is, the image of framers under coisometries are framers.

**THEOREM 2.9.** *Let  $\{A_j\}_{j \in \mathbb{J}}$  be a family of coisometries on  $H$  and let  $(\{f_j : j \in \mathbb{J}\}, \lambda)$  be a framer for which  $\{f_j \lambda\}_{j \in \mathbb{J}}$  is a frame with frame bounds  $\{B_1, B_2\}$ . Set  $C_j = A_j f_j$ , then  $(\{C_j : j \in \mathbb{J}\}, \lambda)$  is a framer with framer bounds  $\{B_1, B_2\}$ . If  $(\{f_j : j \in \mathbb{J}\}, \lambda)$  is tight (normal), then  $(\{C_j : j \in \mathbb{J}\}, \lambda)$  is tight (normal), respectively.*

*Proof.* Let  $x \in H$  be given, then  $\sum_j |\langle x, C_j \lambda \rangle|^2 = \sum_j |\langle x, A_j f_j \lambda \rangle|^2 = \sum_j |\langle A_j^* x, f_j \lambda \rangle|^2$ . Since  $(\{f_j : j \in \mathbb{J}\}, \lambda)$  is a framer for which  $\{f_j \lambda\}_{j \in \mathbb{J}}$  is a frame with frame bounds  $\{B_1, B_2\}$ , so  $B_1 \|A_j^* x\|^2 < \sum_j |\langle A_j^* x, f_j \lambda \rangle|^2 < B_2 \|A_j^* x\|^2$ . But  $A_j$  is coisometry, for all  $j$ , hence  $\|A_j^* x\| = \|x\|$ , and then  $B_1 \|x\|^2 < \sum_j |\langle A_j^* x, f_j \lambda \rangle|^2 < B_2 \|x\|^2$ , or  $B_1 \|x\|^2 < \sum_j |\langle x, C_j \lambda \rangle|^2 < B_2 \|x\|^2$ . So  $(\{C_j : j \in \mathbb{J}\}, \lambda)$  is a framer with bounds  $\{B_1, B_2\}$ .

If  $(\{f_j : j \in \mathbb{J}\}, \lambda)$  is a tight framer, then a similar calculation shows that  $\sum_j |\langle x, C_j \lambda \rangle|^2 = \sum_j |\langle A_j^* x, f_j \lambda \rangle|^2 = B_1 \|A_j^* x\|^2 = B_1 \|x\|^2$ , that is,  $(\{C_j : j \in \mathbb{J}\}, \lambda)$  is a tight framer on  $H$ .

And finally, if  $(\{f_j : j \in \mathbb{J}\}, \lambda)$  is normal, then  $(\{C_j : j \in \mathbb{J}\}, \lambda)$  is a normal framer on  $H$ .  $\square$

We can generalize this theorem as follows.

**THEOREM 2.10.** *Let  $\{A_j^1\}_{j \in \mathbb{J}}, \{A_j^2\}_{j \in \mathbb{J}}, \dots, \{A_j^n\}_{j \in \mathbb{J}}$  be families of coisometries, and let  $(\{f_j : j \in \mathbb{J}\}, \lambda)$  be a framer with framer bounds  $\{B_1, B_2\}$ . If  $C_j = A_j^1 A_j^2 \cdots A_j^n f_j$ , then  $(\{C_j : j \in \mathbb{J}\}, \lambda)$  is a framer with framer bounds  $\{B_1, B_2\}$ . If  $(\{f_j : j \in \mathbb{J}\}, \lambda)$  is tight (normal), then  $(\{C_j : j \in \mathbb{J}\}, \lambda)$  is tight (normal), respectively.*

*Proof.* The proof is an easy consequence by Theorem 2.9 and induction.  $\square$

**Remark 2.11.** For a tight framer  $(\{f_j : j \in \mathbb{J}\}, \lambda)$  with framer bound  $A$ , the reconstruction formula is  $x = (1/A) \sum_j \langle x, f_j \lambda \rangle f_j \lambda$ . If framer is not tight, then there is a similar reconstruction formula in terms of dual framers.

Let  $(\{f_j : j \in \mathbb{J}\}, \lambda)$  be given. A framer  $(\{g_j : j \in \mathbb{J}\}, \lambda)$  is called a dual framer of  $(\{f_j : j \in \mathbb{J}\}, \lambda)$  if for each  $x \in H$ ,  $x = \sum_j \langle x, g_j \lambda \rangle f_j \lambda$ .

**THEOREM 2.12.** *Let  $(\{f_j : j \in \mathbb{J}\}, \lambda)$  be a framer on a Hilbert space  $H$ . Then there exists a unique operator  $S : H \rightarrow H$  such that  $x = \sum_{j \in \mathbb{N}} \langle x, S f_j \lambda \rangle f_j \lambda$ , for all  $x \in H$ . If  $A : H \rightarrow K$  is any invertible operator for some Hilbert space  $K$  such that  $(\{A f_j : j \in \mathbb{J}\}, \lambda)$  is a normal framer, then  $S = A^* A$ . In particular,  $S$  is an invertible positive operator.*

*Proof.* Since  $(\{f_j : j \in \mathbb{J}\}, \lambda)$  is a framer, so  $\{f_j \lambda : j \in \mathbb{J}\}$  is a frame for  $H$ , now the theorem is trivial.

We call  $(\{Sf_j : j \in \mathbb{J}\}, \lambda)$  the canonical dual of  $(\{f_j : j \in \mathbb{J}\}, \lambda)$ , and for each  $x \in H$ , one can write  $x = \sum_{j \in N} \langle x, Sf_j \lambda \rangle f_j \lambda = \sum_{j \in N} \langle x, f_j \lambda \rangle Sf_j \lambda$ .  $\square$

The last theorem proves that the canonical dual of each wavelet-type frame can be of wavelet-type as the following theorem proves the same results for the dual of a frame.

**THEOREM 2.13.** *Let  $(\{f_j : j \in \mathbb{J}\}, h)$  and  $(\{g_j : j \in \mathbb{J}\}, \lambda)$  be framers on a Hilbert space  $H$ , such that  $x = \sum_j \langle x, g_j \lambda \rangle f_j h$  for all  $x \in H$ . Then  $x = \sum_j \langle x, f_j h \rangle g_j \lambda$ , for all  $x \in H$ .*

The proof is obvious.

### 3. Complement in framers and basers

This section investigates some additional properties of framers and basers. First, we give some definitions.

*Definition 3.1.* Let  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  be a framer on a Hilbert space  $H$ . A framer  $(\{g_j : j \in \mathbb{J}\}, \lambda_2)$  on a Hilbert space  $M$  is called a complement to  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  if  $(\{f_j \oplus g_j : j \in \mathbb{J}\}, \lambda_1 \oplus \lambda_2)$  is a Riesz baser on  $H \oplus M$ . Note that by Theorem 2.7, the complement to each framer  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  exists.

If  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  is a normal framer, then a normal framer  $(\{g_j : j \in \mathbb{J}\}, \lambda_2)$  on a Hilbert space  $M$  is called a strong complement to  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  if  $(\{f_j \oplus g_j : j \in \mathbb{J}\}, \lambda_1 \oplus \lambda_2)$  is an orthonormal baser on  $H \oplus M$ .

Two framers  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  and  $(\{g_j : j \in \mathbb{J}\}, \lambda_2)$  on Hilbert spaces  $H, K$ , respectively, are similar if there exists a linear bounded invertible operator  $T : H \rightarrow K$  such that  $Tf_j T^* = g_j$  for each  $j \in J$ . In this case, if  $T$  is unitary, then  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  and  $(\{g_j : j \in \mathbb{J}\}, \lambda_2)$  are called unitarily equivalent.

A framer  $(\{g_j : j \in \mathbb{J}\}, \lambda_2)$  is called strong complement to  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  if there exist a pair of strong complement normal framers  $(\{f'_j : j \in \mathbb{J}\}, \lambda_1)$  and  $(\{g'_j : j \in \mathbb{J}\}, \lambda_2)$  and linear bounded invertible operators  $T_1$  and  $T_2$  such that  $f'_j = T_1 f_j T_1^*$  and  $g'_j = T_2 g_j T_2^*$  for all  $j \in \mathbb{J}$ .

**THEOREM 3.2.** *Let  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  be a framer on  $H$ , and let  $(\{g_j : j \in \mathbb{J}\}, \lambda_2)$  and  $(\{e_j : j \in \mathbb{J}\}, \lambda_3)$  be strong complements to  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  in Hilbert spaces  $M, N$ , respectively. Then there exists an invertible operator  $\Delta : M \rightarrow N$  such that  $e_j = \Delta g_j \Delta^*$  for all  $j \in \mathbb{J}$ .*

The proof is immediate.

In the next theorem, we will show that the strong complementary of normal framers are preserved under coisometries.

**THEOREM 3.3.** *Let  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  be a normal framer on  $H$ , and let  $\{A_j : j \in \mathbb{J}\}$  be a family of coisometries operators on  $H$ . Then there exist a Hilbert space  $M$  with normal framer  $(\{g_j : j \in \mathbb{J}\}, \lambda_2)$ , and a family of coisometries operators  $\{B_j : j \in \mathbb{J}\}$  on  $M$  such that  $(\{g_j : j \in \mathbb{J}\}, \lambda_2)$  is a strong complement to  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  and  $(\{B_j g_j : j \in \mathbb{J}\}, \lambda_2)$  is a strong complement to  $(\{A_j f_j : j \in \mathbb{J}\}, \lambda_1)$ .*

*Proof.* Let  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  be a normal framer and  $\{A_j : j \in \mathbb{J}\}$  is a family of coisometries. With notations as in Theorem 2.2, since  $\theta : H \rightarrow \theta_0(H)$  is unitary, so  $\theta \oplus I$  and  $\theta^{-1} \oplus I$

are unitaries. Hence by Theorems 2.3 and 2.9, there exist a Hilbert space  $M$  and a normal framer  $(\{e_j : j \in \mathbb{J}\}, \lambda_3)$  such that  $(\{A_j f_j \oplus e_j : j \in \mathbb{J}\}, \lambda_1 + \lambda_3)$  is an orthonormal baser on  $H \oplus M$ . On the other hand, since  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  is normal framer, so there exists a normal framer  $(\{g_j : j \in \mathbb{J}\}, \lambda_2)$  which is a strong complement to  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$ , that is,  $(\{f_j \oplus g_j : j \in \mathbb{J}\}, \lambda_1 \oplus \lambda_2)$  is an orthonormal baser on  $H \oplus M$ . Set  $B_j = e_j g_j^{-1}$  since  $\|B_j^* y\|^2 = \sum_{j \in \mathbb{J}} |\langle B_j^* y, g_j \lambda_3 \rangle|^2 = \sum_{j \in \mathbb{J}} |\langle y, B_j g_j \lambda_3 \rangle|^2 = \sum_{j \in \mathbb{J}} |\langle y, e_j \lambda_3 \rangle|^2 = \|y\|^2$ . So  $B_j$ , for each  $j \in \mathbb{J}$ , is a bounded invertible coisometry. Now,  $B_j g_j = e_j$  and  $(\{e_j : j \in \mathbb{J}\}, \lambda_3)$  is a strong complement to  $(\{A_j f_j : j \in \mathbb{J}\}, \lambda_1)$ , so  $(\{B_j g_j : j \in \mathbb{J}\}, \lambda_3)$  is a strong complement to  $(\{A_j f_j : j \in \mathbb{J}\}, \lambda_1)$ .  $\square$

A similar conclusion holds for framers as follows.

**THEOREM 3.4.** *Let  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  be a framer on  $H$ , and let  $\{A_j : j \in \mathbb{J}\}$  be a family of coisometry operators on  $H$ . Then there exist a Hilbert space  $M$  with normal framer  $(\{g_j : j \in \mathbb{J}\}, \lambda_2)$ , and a family of coisometry operators  $\{C_j : j \in \mathbb{J}\}$  on  $M$  such that  $(\{g_j : j \in \mathbb{J}\}, \lambda_2)$  is complement to  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  and  $(\{C_j g_j : j \in \mathbb{J}\}, \lambda_3)$  is complement to  $(\{A_j f_j : j \in \mathbb{J}\}, \lambda_1)$ .*

*Proof.* Let  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  be a framer and  $\{A_j : j \in \mathbb{J}\}$  are coisometries, so  $(\{A_j f_j : j \in \mathbb{J}\}, \lambda_1)$  is a framer on  $H$ . On the other hand, there are normal framers  $(\{g_j : j \in \mathbb{J}\}, \lambda_2)$  and  $(\{e_j : j \in \mathbb{J}\}, \lambda_3)$  on  $M$  such that  $(\{f_j \oplus g_j : j \in \mathbb{J}\}, \lambda_1 \oplus \lambda_2)$  and  $(\{A_j f_j \oplus e_j : j \in \mathbb{J}\}, \lambda_1 \oplus \lambda_3)$  are Riesz basers on  $H \oplus M$ , that is,  $(\{g_j : j \in \mathbb{J}\}, \lambda_2)$  is complement to  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$ .

For the other part of theorem, set  $C_j = e_j g_j^{-1}$ , then a calculation such as Theorem 3.3 shows that  $\{C_j : j \in \mathbb{J}\}$  are coisometries and since  $(\{A_j f_j \oplus C_j g_j : j \in \mathbb{J}\}, \lambda_1 \oplus \lambda_3)$  is a Riesz baser on  $H \oplus M$ , hence  $(\{C_j g_j : j \in \mathbb{J}\}, \lambda_3)$  is a complement to  $(\{A_j f_j : j \in \mathbb{J}\}, \lambda_1)$ .  $\square$

In the following, we will prove that the strong complement of a wavelet-type normalized tight frame is of wavelet-type.

**THEOREM 3.5.** *Let  $\{x_j : j \in \mathbb{J}\}$  be a normalized tight wavelet-type frame for a Hilbert space  $H$ , and let  $\{y_j : j \in \mathbb{J}\}$  be a strong complement to  $\{x_j : j \in \mathbb{J}\}$  in the frame sense, then  $\{y_j : j \in \mathbb{J}\}$  is a wavelet-type frame.*

*Proof.* Let  $\{x_j : j \in \mathbb{J}\}$  be a normalized tight wavelet-type frame for a Hilbert space  $H$ , so there exists a normal framer  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  on  $H$  such that  $x_j = f_j \lambda_1$  for all  $j \in \mathbb{J}$ . Since  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  is normal framer, so there exists a normal framer  $(\{g_j : j \in \mathbb{J}\}, \lambda_2)$  such that  $(\{f_j \oplus g_j : j \in \mathbb{J}\}, \lambda_1 \oplus \lambda_2)$  is an orthonormal baser on  $H \oplus M$ . So  $\{g_j \lambda_2 : j \in \mathbb{J}\}$  is a strong complement to  $\{f_j \lambda_1 : j \in \mathbb{J}\}$  in the sense of frames. But  $\{y_j : j \in \mathbb{J}\}$  is another strong complement to  $\{f_j \lambda_1 : j \in \mathbb{J}\}$ , so by Theorem 3.2, there exists a unitary operator  $U : M \rightarrow N$  such that  $y_j = U g_j (\lambda_2)$  and  $y_j = U g_j U^* (\lambda_3)$ , for  $\lambda_3 \in N$ . Set  $e_j = U g_j U^*$ , then  $(\{e_j : j \in \mathbb{J}\}, \lambda_3)$  is a normal framer and  $e_j \lambda_3 = y_j$ , that is,  $\{y_j : j \in \mathbb{J}\}$  is wavelet-type.  $\square$

For the case that  $\{x_j : j \in \mathbb{J}\}$  is a general wavelet-type frame, first we prove the following lemma, stated that the similar of a wavelet-type frame is of wavelet-type.

**LEMMA 3.6.** *Let  $\{x_j : j \in \mathbb{J}\}$  be a wavelet-type frame for a Hilbert space  $H$ , and let  $\{y_j : j \in \mathbb{J}\}$  be a frame similar to it. Then  $\{y_j : j \in \mathbb{J}\}$  is wavelet-type.*



*Proof.* Since  $\{x_j : j \in \mathbb{J}\}$  is similar to  $\{y_j : j \in \mathbb{J}\}$ , there exists a bounded invertible operator  $T : H \rightarrow H$  such that  $Tx_j = y_j$ , since  $\{x_j : j \in \mathbb{J}\}$  is a wavelet-type frame, there exists a framer  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  such that  $x_j = f_j \lambda_1$ , hence  $Tf_j \lambda_1 = y_j$ . Now set  $g_j = Tf_j$ , then  $(\{g_j : j \in \mathbb{J}\}, \lambda_1)$  is a framer and  $g_j \lambda_1 = y_j$ , for all  $j \in \mathbb{J}$ . Thus,  $\{y_j : j \in \mathbb{J}\}$  is wavelet-type.  $\square$

The following theorem shows that the strong complement of each wavelet-type frame is of wavelet-type.

**THEOREM 3.7.** *Let  $\{x_j : j \in \mathbb{J}\}$  be a wavelet-type frame for a Hilbert space  $H$ , let  $\{y_j : j \in \mathbb{J}\}$  be a strong complement to  $\{x_j : j \in \mathbb{J}\}$ , then  $\{y_j : j \in \mathbb{J}\}$  is wavelet-type.*

*Proof.* Since  $\{x_j : j \in \mathbb{J}\}$  and  $\{y_j : j \in \mathbb{J}\}$  are strong complements, so by the definition, there exists normalized tight frames  $\{x'_j : j \in \mathbb{J}\}$  and  $\{y'_j : j \in \mathbb{J}\}$  such that  $\{x_j : j \in \mathbb{J}\}$  is similar to  $\{x'_j : j \in \mathbb{J}\}$ ,  $\{y_j : j \in \mathbb{J}\}$  is similar to  $\{y'_j : j \in \mathbb{J}\}$ , and  $\{x'_j \oplus y'_j : j \in \mathbb{J}\}$  is an orthonormal basis. Since  $\{x_j : j \in \mathbb{J}\}$  is a wavelet-type frame and  $\{x'_j : j \in \mathbb{J}\}$  is similar to it, so by Lemma 3.6, the frame  $\{x'_j : j \in \mathbb{J}\}$  is wavelet-type. On the other hand, since  $\{y'_j : j \in \mathbb{J}\}$  is a strong complement to  $\{x'_j : j \in \mathbb{J}\}$  and  $\{x'_j : j \in \mathbb{J}\}$  is wavelet-type, so by Theorem 3.5, the frame  $\{y'_j : j \in \mathbb{J}\}$  is wavelet-type. Therefore, there exists a normal framer  $(\{g_j : j \in \mathbb{J}\}, \lambda_2)$  such that  $g_j \lambda_2 = y'_j$ . Since  $\{y'_j : j \in \mathbb{J}\}$  and  $\{y_j : j \in \mathbb{J}\}$  are similar, so there is a bounded invertible operator  $T$  such that  $Ty'_j = y_j = g_j \lambda_2$ . Thus  $y_j = T^{-1}g_j \lambda_2$ . Now set  $e_j = T^{-1}g_j$ , then  $y_j = e_j \lambda_2$ . That is,  $\{y_j : j \in \mathbb{J}\}$  is wavelet-type.  $\square$

**Definition 3.8.** Let  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  and  $(\{g_j : j \in \mathbb{J}\}, \lambda_2)$  be normal framers on Hilbert spaces  $H$  and  $K$ , respectively.  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  and  $(\{g_j : j \in \mathbb{J}\}, \lambda_2)$  are strongly disjoint (strongly completely disjoint) if  $(\{f_j \oplus g_j : j \in \mathbb{J}\}, \lambda_1 \oplus \lambda_2)$  is a normal framer (orthonormal baser) on  $H \oplus M$ .

If  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  and  $(\{g_j : j \in \mathbb{J}\}, \lambda_2)$  are framers (not necessarily tight or normal),  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  and  $(\{g_j : j \in \mathbb{J}\}, \lambda_2)$  are disjoint if  $(\{f_j \oplus g_j : j \in \mathbb{J}\}, \lambda_1 \oplus \lambda_2)$  is a framer on  $H \oplus M$ .

Two framers  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  and  $(\{g_j : j \in \mathbb{J}\}, \lambda_2)$  are called strongly disjoint (strongly completely disjoint) if they are similar to a pair of strongly disjoint (strongly completely disjoint) normal framers.

Finally our last task in this paper is to prove that the strongly disjointness of each wavelet-type normalized tight frame is of wavelet-type. This will be shown in the following theorem.

**THEOREM 3.9.** *Let  $\{x_j : j \in \mathbb{J}\}$  be a wavelet-type normalized tight frame for a Hilbert space  $H$ , and let  $\{y_j : j \in \mathbb{J}\}$  be a strongly disjoint frame to it. Then there exists a normalized tight frame  $\{z_j : j \in \mathbb{J}\}$  such that  $\{y_j \oplus z_j : j \in \mathbb{J}\}$  is of wavelet-type.*

*Proof.* Let  $\{x_j : j \in \mathbb{J}\}$  be a wavelet-type normalized tight frame. So there exists a normal framer  $(\{f_j : j \in \mathbb{J}\}, \lambda_1)$  such that  $x_j = f_j \lambda_1$  for all  $j \in \mathbb{J}$ . Since  $\{y_j : j \in \mathbb{J}\}$  is strongly disjoint to  $\{x_j : j \in \mathbb{J}\}$ , thus  $\{x_j \oplus y_j : j \in \mathbb{J}\}$  is a normalized tight frame and there exists a normalized tight frame  $\{z_j : j \in \mathbb{J}\}$  such that  $\{(x_j \oplus y_j) \oplus z_j : j \in \mathbb{J}\}$  is an orthonormal basis.



But  $\{(x_j \oplus y_j) \oplus z_j : j \in \mathbb{J}\}$  and  $\{x_j \oplus (y_j \oplus z_j) : j \in \mathbb{J}\}$  are unitarily equivalent, hence  $\{x_j \oplus (y_j \oplus z_j) : j \in \mathbb{J}\}$  is an orthonormal basis. Since  $\{x_j : j \in \mathbb{J}\}$  is a normalized tight frame, so  $\{y_j \oplus z_j : j \in \mathbb{J}\}$  is a normalized tight frame, which is a strong complement to  $\{x_j : j \in \mathbb{J}\}$ . Now  $\{x_j : j \in \mathbb{J}\}$  is a wavelet-type normalized tight frame, so by Theorem 3.7, the frame  $\{y_j \oplus z_j : j \in \mathbb{J}\}$  is wavelet-type as required.  $\square$

## Special Issue on Intelligent Computational Methods for Financial Engineering

### Call for Papers

As a multidisciplinary field, financial engineering is becoming increasingly important in today's economic and financial world, especially in areas such as portfolio management, asset valuation and prediction, fraud detection, and credit risk management. For example, in a credit risk context, the recently approved Basel II guidelines advise financial institutions to build comprehensible credit risk models in order to optimize their capital allocation policy. Computational methods are being intensively studied and applied to improve the quality of the financial decisions that need to be made. Until now, computational methods and models are central to the analysis of economic and financial decisions.

However, more and more researchers have found that the financial environment is not ruled by mathematical distributions or statistical models. In such situations, some attempts have also been made to develop financial engineering models using intelligent computing approaches. For example, an artificial neural network (ANN) is a nonparametric estimation technique which does not make any distributional assumptions regarding the underlying asset. Instead, ANN approach develops a model using sets of unknown parameters and lets the optimization routine seek the best fitting parameters to obtain the desired results. The main aim of this special issue is not to merely illustrate the superior performance of a new intelligent computational method, but also to demonstrate how it can be used effectively in a financial engineering environment to improve and facilitate financial decision making. In this sense, the submissions should especially address how the results of estimated computational models (e.g., ANN, support vector machines, evolutionary algorithm, and fuzzy models) can be used to develop intelligent, easy-to-use, and/or comprehensible computational systems (e.g., decision support systems, agent-based system, and web-based systems)

This special issue will include (but not be limited to) the following topics:

- **Computational methods:** artificial intelligence, neural networks, evolutionary algorithms, fuzzy inference, hybrid learning, ensemble learning, cooperative learning, multiagent learning

- **Application fields:** asset valuation and prediction, asset allocation and portfolio selection, bankruptcy prediction, fraud detection, credit risk management
- **Implementation aspects:** decision support systems, expert systems, information systems, intelligent agents, web service, monitoring, deployment, implementation
