What is the system? Everyone talks about it and has no idea what it is about.

"We generously fund our own people, so it's understandable that we rule not only in this country. We run American foreign policy. We are the supreme government of the world. Will this be enough (for you)? ... Owners are constantly



forced to push up prices because we are constantly increasing the cost of capital. Workers must increase wages and owners must increase prices, which creates a devilish circle. We are never charged with our role which is the real cause of inflation. The conflict between the employee and the owner is so great that neither has time to observe what we are doing. The increase in the cost of capital caused by us causes inflationary cycles. We are not employees or owners, yet we receive profits. Thanks to our manipulation of money, the capital we give to industry costs us nothing. Through our national bank, the Federal Reserve, we extend the credit we made out of it to all local banks that are member banks. And they, in turn, extend credit to the industry. Their book (the Bible) also teaches a voluntary despotic form of government according to the law of that book, while democracy is the

rule of the mob that we control through their churches and media and economic institutions. Their religion is just another channel through which we can channel the power of our propaganda. (...) Before 1968. gullible goyim could take the Federal Reserve's \$ 1 bill to any bank in America and exchange it for a dollar they said. the law contained 412 and a half grain 90% silver (gran = 0.0648 g), while in 1933 the same banknote could be exchanged for a coin containing 25 and 4/5 grain 90% gold. All we do is give the goys more non-redeemable bills, or better, copper disks. But we never give them their gold and silver. Just more paper. We Jews enjoyed success thanks to the paper swagger. This is our method by which we take money and give paper in return. (...) The power of money is essential for carrying out our master plan of world conquest through propaganda. (...) First, by controlling the banking system, we are able to control corporate capital. Then, thanks to this, we gained a complete monopoly in the film industry, on the radio network in the recently developing television. The publishing industry, newspapers, periodicals and technical periodicals have already fallen into our hands. The best treat came later when we mastered the publication of all school materials. In this way, we can shape public opinion to suit our interests. People are just stupid pigs who squeal and squeal the songs we give them, whether they are true or lying. (...) There is no such thing as a silent majority because WE control their cry. The only thing that exists is the non-thinking majority, and they will remain non-thinking until they get out of our rigorous ministry, which is the drug of our entertainment industry. By controlling this industry, have become overseers (goyim) we and the nation slaves. Interview with H.W. Rosenthal from 1976. published by C.H. Weisman in 1992. In 1977.

The US dollar is the world's reserve currency. It obtained this status after World War II, when it was the currency of the world's leading economy. It was also gold-backed, so central banks could hold US dollars and exchange them for gold at any time. Holding dollars and holding gold are basically the same.

In 1971, US President Richard Nixon abolished the convertibility of the dollar into gold. Since then, money de facto has no value, it is as much as the material from which it was made. The world still uses dollars, which, as measured in gold, lost 94% of their pre-1971 value. Does such a security remain a safe reserve currency? Of course not. The hegemony of the dollar as a currency in the world is only an interpretation of the US military strength and its criminal actions on the world scene, not the face value of the dollar. When the US military hegemony collapses, it will turn out that there is no currency called the US dollar at all. The Tryphin Law implies that no reserve currency - unless it is definitely tied to gold - will survive for long.

In 1910, seven men met on the island of Jekyll off the coast of Georgia to plan the Federal Reserve Bank. Nelson Aldrich and Frank A. Vanderlip represented the financial empire of Rockefeller (Illuminati). Henry Davidson, Charles Norton, and Benjamin Strong represented JP Morgan (Illuminati). Paul Warburg (Illuminati) represented the European Rothschild (Illuminati) banking dynasty.

The Rothschilds were Jesuit banking agents and held "the key to the wealth of the Roman Catholic Church."

Since the creation of the Federal Reserve Board in 1914, Every dollar has been borrowed from this private central bank. Every dollar the Fed ever created was returned to that bank with interest. No government can create money. Central banks are private institutions. They lend money to governments created out of nothing and charged with interest. When all the debt has been paid, there is no money to pay the interest; for them to arise, you must first borrow money. Therefore, public debt continues to rise. This debt can never be repaid. It is impossible. In other words, it is a fraud committed with the knowledge of the government itself!

The Rothschild-Rockefeller-Morgan trio made themselves rulers of money first in Europe and later in America by introducing private, central, government-sanctioned banks in England, France, Germany, Italy and Austria. They were not going to let anyone stand in the way of their grand prize, which is world power.

The group of 400 of the richest people in the world who opposed the creation of a central Federal Reserve Bank in the early 1900s was on the Titanic (quite a strange coincidence as usual). As we know, the unsinkable ship carrying the richest people of the entourage was not equipped with the necessary number of lifeboats. The privatization of the US Federal Reserve was initiated by a group of Illuminati "bankers" with a plan to create a New World Order. Acting independently of the government, the "privatized" Federal Reserve Central Bank controls almost every other central bank in the rest of the world, each government covering the entire financial system.

The bankers' decision, initialed by Nixon, gave the Jews impunity in the unlimited counterfeiting of money - now they borrow paper and obtain goods in exchange for it. How does it look in practice? For example, one dollar of US GDP earned is burdened with around 5.5 dollars in debt. In this way the Jews rule over the whole world. In the world, 97% of the money supply is owed to Jewish banks. Prices only rise because of criminal speculative operations. In fact, banks do not lend the currency that is deposited in the accounts. Instead, they create a new fiat currency out of nothing and then borrow it, which means that they are not borrowing money, commodity, but only their virtual "something" for this debt is actually collected. And now we should understand why Jewish bankers with the hands of the US army murder anyone who wants to produce real convertible money, e.g. as Gaddafi did by basing a dinar on gold. And this practice thoughtlessly called the system is nothing more than the Schulchan law, which has been practiced on a naive and stupid gentleman for over 100 years.

Central banks (all owned by the Rothschild family) such as the Central Bank of London, the Vatican Bank and the Federal Reserve, to name a few. London's central bank manipulates the gold rate on a daily basis, making it a global financial player. They were established as free states, so they have immunity from literally everyone. This includes all banking system employees who are also immunity from punishment.

This criminal practice perfectly captures the thought of Frédéric Bastiat: "When plunder becomes a way of life for a group of people, over time they will create for themselves a legal system that will justify their actions and a moral code that will glorify it."

The Rothschilds own multinational corporations. Governments have fun paying use taxes, 13% of the tax dollars contributed goes directly back to the private banking system. Bend at its best. The last rung of this pyramid is.... We. We are considered lower payers and we do our part by paying 90% of the top 10% or the very top of the pyramid. In this way, the Rothschilds built their wealth to \$ 500 trillion.

We must find out the truth in order to regain our freedom, how to reject this crime-based Jewish oppression that the Jews have practically introduced into the world.

There are two megabanks that offer loans to all countries around the world - the World Bank and the International Monetary Fund. The former is jointly owned by the world's largest banking families, with the Rothschilds at the top, while the latter is privately owned solely by the Rothschilds. The only bank that governs them, the "Bank for International Settlements", is - of course - controlled by the Rothschilds and is called the "Tower of Basel".

In the 1920s, literature professor Jiro Imai of the University of Tokyo wrote in his book "On the World-WideSecret Society" that he stated that Freemasonry is the most dangerous and subversive secret society. "

The Committee of the Three Hundred is a narrow part of the summit of the corporate and financial rulers of the world. Following in the footsteps of the leading names of the Bilderberg Group, Chatham Hause, CFR, and the Tripartite Commission, we come to the Committee of the Three Hundred, their parent organization, a kind of command staff. In 1992, John Coleman, an agent of the British MI6 intelligence service, was published: "The Hierarchy of Conspirators: The Committee of 300".

The Committee of 300, according to Coleman, has ruled Europe and America since 1897. But its roots go deeper. The Committee of 300, known as the "Olimpians", is a creation transformed by the English nobility from the first imperial monopoly of the world's elite, the British East India Company.

The company collapsed, but the remaining families with great wealth gained from the opium trade during the so-called opium wars with China. This wealth was multiplied by the colonialism of Africa, where Cecil Rhodes, a member of the Committee of 300, was used. Rhodes, supported by Lord Rothschild's finances, became the greatest landowner of Africa, thus dominating the mining of diamonds (today this profession is continued by the Oppenheimer - members of the Committee of 300). These influences were used to start the implementation of the procedures towards world government by opening Alfred Milner's Round Table groups and the international socialist Fabian Society, and then

such as CFR, Tripartite Commission, Club of Rome, Bilderberg, Canadian Institute of International Affairs, International Institute of Studies Strategic, Mont Pelerin Association, Ditchley Foundation, Wilton Park, Aspen Institute, Union of Concerned Scientists and many others that have absorbed international politics and thousands of concerns into their programs. Based on Coleman's information, the head of the global system of Round Table groups is the Royal Institute of International Affairs (Chatham House) in London, which gives orders to the other groups. His visions of the New World Order - a single, world socialist state are defined by the Fabian Society. Only the 13 Illuminati circle according to Coleman knows the complete

It doesn't matter who sits in the White House, because the Committee of 300 exercises complete control through the Council on Foreign Relations (CFR), the Royal Institute of International Affairs (Chatham House), the Club of Rome, and the Cincinate Society.

The Committee of 300 controls American politics through the Freemasonry of the Skull & Bones, which is the inner circle of the CFR's Foreign Relations Council, which brings together the US political, industrial, and corporate establishment. In America, there are also many other organizations subordinate to the Committee of 300, and internationally, the Bilderberg Group and the Trilateral Commission. The Roman Club dominates among this type of groupings. The second, after the British Order of the Garter, the Inner Circle of the Olimpians is the "Invisible Nine", the composition of which is unknown, only that it is known to include three tycoons:

- Rothschild ("head" of Europe ruling over gold),
- Oppenheimer ("head" of Africa ruling over diamonds)
- Rockefeller (America's "head" controlling oil).

The group's ultimate goal is to introduce a planetary government, enslave and stupef Earth's inhabitants, and finally, drastically

Goals Coleman writes about (quoted directly from his book):

- "1. the establishment of a One World New World Order with a unified church and monetary system under their authority. One World Government began organizing the church in the 1920s and 1930s when they realized the need to create an appropriate religion as a valve to mankind, and therefore established a "church" body to which they could direct beliefs according to their agenda.
- 2. causing the complete destruction of every national identity and pride, which was the first issue to be resolved for the operation of a One World Government.
- 3. designing the process of destroying religion, especially Christian religion, and leaving one invented by them.
- 4. Establishing the possibility of controlling every human being by means of mind control and what Zbigniew Brzezinski calls technotronics, i.e. creating robots like humans and a terror system where Feliks Dzerzhinsky's red terror would look like a child's game.
- 5. to bring about the complete end to industrialization and nuclear electricity production, what they call the "post-industrial zero-growth society". The exceptions are the computer and service industries. US industry will continue to be exported to countries like Mexico with abundant slave labor available. 7. introducing depopulation of large cities in the way Pol Pot practiced in Cambodia. It is worth noting that the genocide plan he carried out was developed by one of the research foundations of the Club of Rome in the USA, overseen by Tomas Anders, a high official of the Department of State. Currently, the committee is seeking the return to power in Cambodia of the murderers of the Pol Pot regime. [The book was published in the early 1990s - interjection].

The existence of an invisible world government was also mentioned by other high-ranking agents from various intelligence agencies, including the KGB - Vladimir Nikorov and Jacques Costeau, awarded the UNESCO medal by President Kennedy. In his book, Coleman assesses their influence in today's world in the following way: "From Colombia to Miami, Golden Triangle to Golden Gate, from Hong Kong to New York, from Bogota to Frankfurt, drug trafficking, especially arms trafficking, is big business and it is run from top to bottom by several untouchable families of the world, each with at least one member on the Committee of 300. This is not a corner business, it requires smoothly organized money and experience (...). They are the omnipotent Olimpians group, centered on the financial district of the City of London, dominating the cocaine, opium, pharmacy, banking, cult promoters and rock music makers ... possible planes. It is one organized hierarchy of power in the world, surpassing all governments and all individuals. "

John F. Kennedy "One day after my departure, you will remember me and say that we should have stopped Israel's nuclear program, liquidated the Federal Reserve, and kicked out all secret societies and Zionists from our wonderful country. To make it so, but it is never too late for it, just remember that this is "Financial Fraud Explained" [From 2020. the withdrawal of cash from circulation has started, it means that now the goyim will not even get the paper because the goyim were stupid and will remain stupid - because does a wise man give his life and property to a Jew? In the Middle Ages (in Venice in 1565), Talmudic legislation was consolidated for ease of use, and to conceal a violent Talmudic hatred of Christianity, in a special code called "Shulchan-Aruch". According to the testimony of Dr. Ramer, a rabbi in Magdeburg (Pirer's Encyclopedic Dictionary, vol. XVI, 1879): "Shulchan Aruch is accepted by Israeli communities as the legal basis and measure of their religious practice." Not the law of Moses, but the Shulchan-Aruch





law has been the legal and religious measure of contemporary Jewry since its introduction. All those who mistakenly assume that Jewry is brought up in the books of the Old Testament that we know must know and remember this.

The historic appeal made by Benjamin Franklin to the leadership of the young state some 235 years ago: "Gentlemen, we have a problem more difficult than the Roman problem: it is a Jew. In which only country did the Jews settle, lowered its moral level, and destroyed its

merchant standard, they mocked his religion, undermined it. They created the state in the state. They are vampires - and vampires do not live off vampires. They can never live and support themselves. They can only survive and live among Christians and other nations, which they do not belong to their race. If they do not depart from our country by virtue of our constitution, it will be certain that in less than 200 years they will come to us in such a mass that they will dominate the country and absorb the country, change the form of government, for which we Americans have shed blood, donatedlife and we have jeopardized our freedom, and our descendants will work to make them fortune while they rub their hands in their exchange offices. I warn you, gentlemen, if you do not remove the Jews from your country at all times, your children and descendants will curse you in the tomb! "

These warnings were disregarded, and the expansion of Jews to the USA grew the more the country became - thanks to the entrepreneurship and diligence of white immigrants from Europe (including Poles, as strongly emphasized in his book by Henry Ford) - wealthier and modern. This is eloquent in the statistics published by the American Jewish Committee, which is a rather credible institution on Jewish issues.

In the year of the creation of the United States of America (1776), the estimated number of Jews was from 1,000 to 2,500. A hundred years later (the beginnings of capitalism) there were already about a quarter of a million, and in 1920 - when the free market economy began to bring tangible results - Jewish accountants calculated the number of their countrymen in the USA in the range of 3,300,000 - 3,604,580. In 2001, the American Jewish Committee estimated the number of Jews in the United States at exactly 6,155,000. This is less than 2 percent. US citizens, but in this case it is not the number that counts, but their social position. More precisely, the location of Jews in key segments of each state; from finance, through administration, education, science and economy to the media.

Henry Ford in his book The "International Jew" has demonstrated unequivocally that the decisive position of the Jews in the most important structures of the American state is by no means the result of their intellectual predispositions, but of conspiratorial tribal solidarity ordering to locate "their own" wherever there is access to money and consciousness of gentiles, i.e. non-Jews. Jewry as a criminal organization is expressed, for example, in social preference by an eloquent little-known fact; the most cruel economic organization operating in the USA against the law was not the Italian mafia, but the Jewish one, and the notorious Al Capone is a "little trick" with a Jewish bandit and a degenerate named Lansky aka Meyer. Although the American government conducted a criminal trial against this bandit, Lansky escaped punishment. How can we guess according to the principle that the Jew is not bound by the goyim law.

The second social preference, that is, reaching the consciousness (read: stupefying) of the gentiles is embodied in the great media industry, including the film industry, which is absolutely dominated by Jews. As a result, in over 400 films devoted to this nation, produced in Hollywood, there is not a single one that would show Jewry in a bad light. To be precise, this also applies to gangster films.

Regarding Benjamin Franklin's warnings, it is impossible to remain silent about the extreme naiveté and susceptibility of Americans to Jewish brainwashing. Its effect is not only the consent to finance from the pockets of American taxpayers a creation called Israel (annual donations to this geshift amount to \$ 5-6 billion) but also sacrificing the lives of thousands of young "volunteers" in the name of Jewish interests in the Middle East or permission to corrupt the American society by the Jewish media. In fact, even better informed (vide: Franklin), the freemasons eventually became blunt tools in the hands of the Sanhedrin, carrying out the goals outlined by the Jews with admirable commitment. This also applies to the absolute majority of US presidents, with Clinton and the two Bushes at the helm.

Let us use this information as a punch line; about 80 percent Male Americans have undergone circumcision. Among them there are many people who claim to be Roman Catholic Christians. America is no longer a nation as such, it is a Zionist-Jewish holding company; Corporation owned by Jews. America Corp is largely Jewish-owned. To know Jewry is to know Talmud, and to know Talmud is to know everything. "Whoever understands the Talmud understands everything", Joshua Maimon taught his son

Solomon, who later became a philosopher, in deep Lithuania, urging him to study the Talmud (Autobiography of Salomon Majmon, Polish translation by L. Belmont, Warsaw 1913, p. 22).

The worst part of it is that most Americans and the so-called nations the West understands nothing of the Poles. Most still believe that the Federal Reserve is a government institution. It is not and has never been a government institution. It has always been owned and run by Zionist Jews and a handful of local oligarchs. The same little clique of Zionist Jews owns and manages all central banks.
